In 2017 we provided grants to: Alexander Valley Health Care and Alliance Medical Center - community health centers serving the under and uninsured, seniors and families; to Healdsburg District Hospital for technology upgrades and state of the art equipment; to PDI Surgery Center for prevention and education of severe tooth decay in children; to Sonoma State University for scholarships for nurse practitioners who stay in our area; and to Corazon Healdsburg for outreach work with low income Latino families. 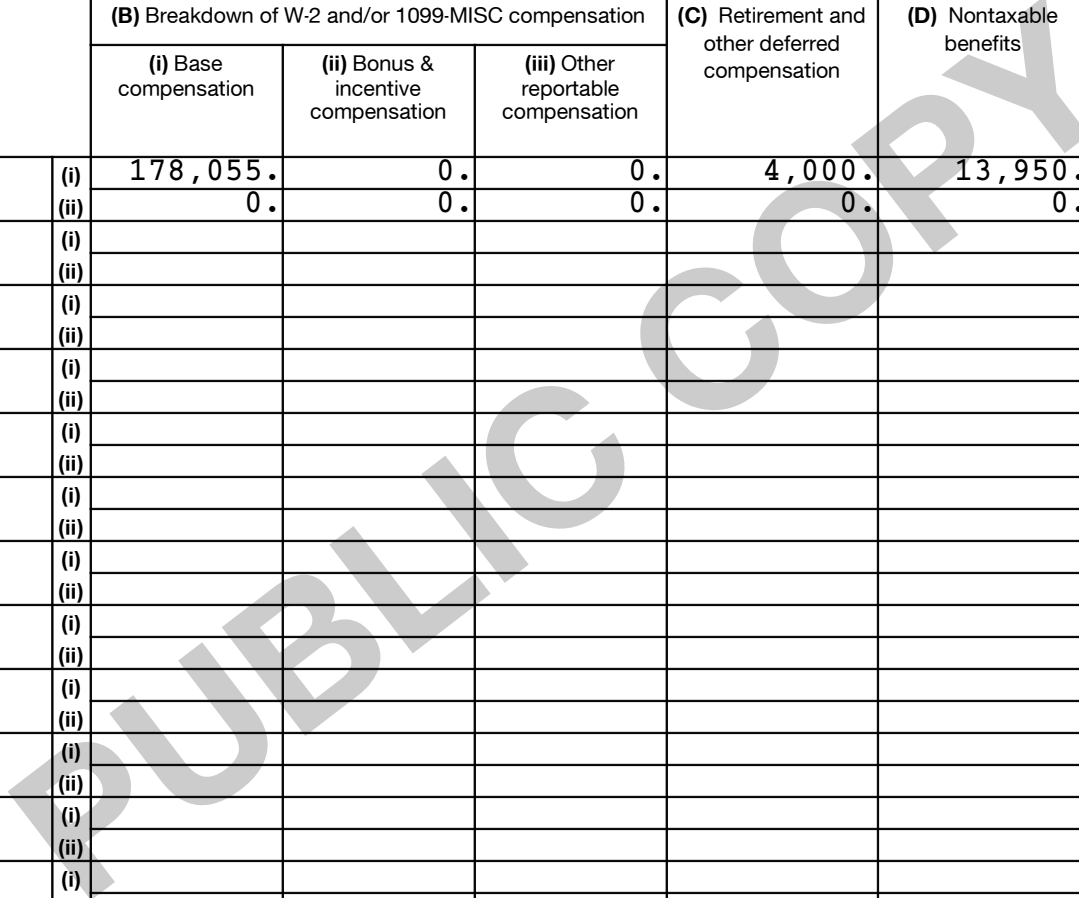
